# Analysis and explanation of operating results

#### Sales and profit

Group net sales totaled 204,983 million yen (year on year +9.3%), and operating income was 7,306 million yen (year on year -8.4%). The domestic business saw increased revenue because of growth in sales at existing outlets driven by developing sales measures and seasonal products at each business, in addition to an increase in the number of outlets through new openings. And, though increases in minimum wages and changes of Yoshinoya's uniform led to higher costs, revenue growth offset these increases, resulting in higher profits. The overseas business was significantly impacted by higher labor costs owing to a substantial minimum wage increase in the United States (California) and the economic downturn in China, which led to a decline in the food service industry profits. Moreover, the addition of

Takara Sangyo, which possesses ramen ingredient manufacturing and development capabilities, to the Group contributed to higher net sales and operating income.

#### Total assets, liabilities, and net assets

Total assets at the end of the current fiscal year increased by 6,176 million yen compared with the end of the previous fiscal year to 119,113 million yen. This was mainly attributable to a 10,757 million yen increase in property, plant and equipment as a result of aggressive investment in opening and renovating outlets, and M&A. As a result of using our own funds for these growth investments, cash and deposits fell by 6,774 million yen. Due to securing net income, however, net assets increased by 3,963 million yen to 64,813 million yen, and the equity ratio rose by 0.5%

to 53.9%. Additionally, as a result of the repayment of loans payable, the debt-to-equity ratio was down 0.03, maintaining a high level of safety.

#### **Cash flows**

Cash and cash equivalents at the end of the fiscal year under review decreased by 6,750 million yen compared with the end of the previous fiscal year to 19,524 million yen, after taking into account the effect of exchange rate change. Net cash provided by operating activities amounted to 13,304 million yen, a decrease of 6,767 million yen compared with the previous fiscal year. The main factors included a decrease of 1,895 million yen owing to a decrease in income before income taxes, a decrease of 1,506 million yen because of an increase in trade receivables, a decrease of 3,011 million yen due to an increase in

income taxes paid, and a decrease of 1,301 million yen due to a decrease in proceeds from subsidy income. Net cash used in investing activities amounted to 14,398 million yen, a decrease of 6,090 million yen compared with the previous fiscal year. The main factors included a decrease of 3,974 million yen due to an increase in purchase of property, plant, and equipment, and a decrease of 2,678 million yen due to an increase in purchase of shares of subsidiaries resulting in change in scope of consolidation. Net cash used in financing activities amounted to 5,973 million yen, an increase of 2,983 million yen compared with the previous fiscal year. The main factors included an increase of 1,993 million yen due to a net increase in short-term loans payable and an increase of 1,251 million yen due to repayment of long-term loans payable, among others.

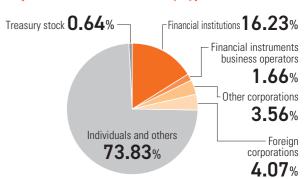

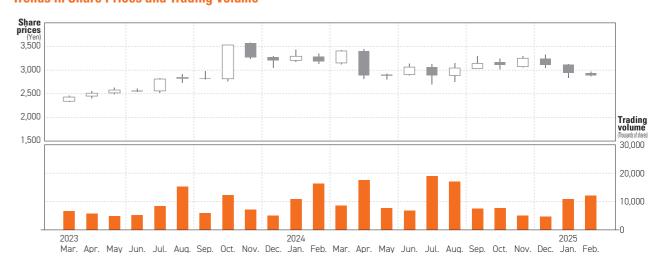
